# **Greetings from Griz** Dave Pauly, MSGS President & Habitat Projects Coordinator

Your Society is presently engaged in ENERGIZED MISSION MOMEN-TUM, using all possible strategies to address declining sharptail populations and loss of quality habitats.

The following highlights were/are predicated in our Vision to restore, maintain and sustain the resiliency of the Sharp-tailed Grouse to its former status as one of the most highly desired upland gamebird species in Minnesota.

### **HIGHLIGHTS** (condensed list)

### Recruit - Retain -- Re-activate

Membership of now 250 strong with 43 Life Members, our Facebook page with  $\sim$ 2500 follows, and  $\sim$ 2500 likes, reaching  $\sim$ 3500 – progress made both the "old way" and through the new Social Media way!

### Funding Sources (separate form Membership dues)

Conservation Partnership Legacy (CPL) Grants (MSGS origination) -\$1.3M. PF-MSGS OHF Grant Partnership – many \$\$M. USFWS MN Private Lands Office Coop Agreement - \$10K (MSGS discretionary use) and \$10K (MSGS targeted Private Lands Habitat Projects). Multiple \$\$K donations as Cash Match to our CPL Projects from several Conservation Organizations and multiple individuals (to MSGS-SOS account). Give To Max Day – increased our coffers by \$3000+. And many thousands of \$\$ the Brush Cut Days provide as In Kind Match to our CPL Projects.

### **Innovative Projects**

Brushlands Enhancement CPL \$\$ were utilized to contract with a vendor of appropriate equipment to be operated by DNR Staff. A Contractor was awarded CPL \$\$ for the use of a Biobaler to enhance brushlands and then utilize 'bales' for stream/lakeshore erosion control. And we have an MSGS CPL Grant for habitat restoration work in SW MN on the Crosby-Ripple Unit of LQP Management Area in efforts (with PF) to begin supporting sharptail habitat management in that portion of MN.

### **Acquisition Projects**

MSGS finally (5 year process) achieved our first ever stand-alone protection project - the Huddle Acquisition thru conveyance to DNR Wildlife for addition to the Kroschel-Holy Cow WMA. The acquisition reguired a Traditional CPL as our usual venue of ECPL (\$50,000 cap) was not sufficient to satisfy the necessary \$\$ amounts. We have also provided funds for several PF OHF Acquisitions with sharptail/prairie grouse habitats/populations, including the recent Prosby tract addition to the Cupido WMA.

Please recognize, this is by no means an 'all inclusive' list of "your" MSGS Highlights!

# A Visit with George Davis:

# One of the Originals by Jodie Provost



Last summer I had the pleasure of visiting with George Davis, the original Wildlife Manager for the MN DNR Karlstad Wildlife Area. George began his adventures there in 1967 and retired in 1999 - a heck of a run! While his Assistant Wildlife Manager for seven years, he taught me many important lessons at both work and play, from keeping my cookies down on moose survey in the Cessna to waterfowl hunting on Twin Lakes WMA. He was my "DNR Dad" in the beautiful Aspen Parklands.

Hailing from Marshall, MN, George was influenced by his childhood time outdoors with activities such as hunting, fishing, and collecting butterflies. He learned about "wildlife managers" when pulling two out of the ditch one day, thinking "I could do that job!" After serving in the Navy and graduating from University of MN, George was offered a job at Karlstad. He had no idea where it was or that it had moose. Prescribed burning, rotational grazing, prairie and sa-

vanna restoration, involvement in his community, and land acquisition were critical tools of his trade. Under his watch, the WMAs grew from five of about 25,000 acres to over 20 at roughly 100,000 acres. His last prescribed burn was 4,000 acres in size. For wildlife managers that have followed George, his strong and practical shoulders have most definitely been those that we "stand on". Thank you, George! # Remembering a Friend to the Firebird by Kyle Arola

The Minnesota DNR family lost one of its members on January 7, 2022. Shane Peterson, 39, was a member of the Region 1 Roving Crew for the last 11 years. Prior to that position, he worked as a general laborer out of the Karlstad wildlife office. Throughout his years of work with the DNR he impacted thousands of acres of habitat through prescribed burning, brush mowing/shearing, firebreak installation, noxious weed treatment, and the list goes on. Sharp-tailed grouse depend on many of the acres that Shane directly impacted in NW Minnesota. Most recently, Shane had been assisting area Wildlife offices with updating old burn plans and identifying new burn units. The map below shows a 4700 acre unit that he identified for the Thief Lake area. Firebreak installation and brush shearing are occurring this winter and sharp-tailed grouse will benefit significantly from Shane's vision for the unit! On behalf of the Firebird and all the other wildlife that have benefited from your work, you will be missed!

# Upcoming March-April 2022 Volunteer Brush Cut Habitat Days

Join in a Group Day March 19 or 26 OR work Self-Guided any time March 10 – April 10



The University of MN Crookston crew took home the Golden Saw on March 13, 2021 at Palmville WMA. Thirty spirited volunteers, including Bemidji State University students, cut encroaching tamarack from 19 acres on March 10, 13 and 27, to generate \$6,410 of in-kind match. These funds went toward the 10% match required for a CPL grant to enhance more habitat.

What: Hand cut brush to enhance sharp-tailed grouse habitat on Group Days March 19 at La Qui Parle WMA (near Appleton) or March 26 at Gun Lake WMA (near Palisade), Mille Lacs WMA (near Onamia), and by Carp Swamp WMA (near Baudette). OR do Self-Guided work any day on the four sites from March 10 to April 10. OR do both! Enjoy the reward of giving back for wildlife conservation and know your volunteer power will serve as match for a Conservation Partners Legacy (CPL) Grant for more habitat work. Not to mention the outdoors, fresh air, exercise, and great fellowship and food on Group Days!

### To Sign Up & Log Hours:

- 1. <u>Covid safety</u> At least a week prior to volunteering, go to <u>mndnr.gov/vp</u> to review DNR policy and show proof of vaccination. Because the project is on DNR administered land and approved by the DNR Area Wildlife Manager, DNR safety protocol for volunteers must be followed.
- 2. <u>Group Day, Sat., March 19 or 26</u> To volunteer these days, register by one week prior (for a food head count) by emailing Jodie at <u>jodie.provost@yahoo.com</u>. She will send you a site flier with directions and maps. Complete a volunteer agreement form and log hours with the MSGS Rep on site that day. Gather at the site by 9:30 am for a welcome, project and safety briefing. Morning snacks and lunch at noon will be provided. Work convenes by 3 pm. 3. <u>Self-Guided March 10 April 10</u> To volunteer during this time period, at least a week prior email Jodie at <u>jodie.provost@yahoo.com</u> to get the volunteer agreement form, complete, and email it back. She will send you a site flier with directions and maps. After working, email your number of hours worked plus travel time to her.

**To Cut Brush:** Take this flier with directions and maps (see below), warm layers, hat, gloves, water-proof warm boots, snowshoes if deep snow, water bottle, snacks, charged cell phone, and very importantly, hand tools of a hand saw and/or loppers. Saws work well for larger diameter brush and small trees, and loppers best for smaller/whippy diameter brush. Power tools, such as chain saws, are <u>not</u> allowed. Cut all brush and small trees feasible (usually < 3 inches in diameter) within the project area. On Group Day, some hand tools will be available from MSGS, but please bring your own favorites if feasible to ensure enough tools for all.

# Sharptail at St. Croix State Park

Savanna restoration and maintenance at St. Croix State Park in Pine County continues to occasionally attract sharp-tailed grouse. In late November /early December, Asst. Park Manager Karl Sieve reported three sightings of four birds - in the one burn unit they were able to prescribed burn last spring and on the nearby Park road to the headquarters (photo to right). In Karl's words, "hopefully they're here to stay." Continued habitat management and friendly competition with Crex Meadows Wildlife Area, just across the St. Croix River in WI, to see who "makes smoke first" may do just that.



### **Huddle Tract Added to the Kroschel WMA**

## MSGS's 1st Stand Alone Acquisition with a CPL Grant by Dave Pauly

This tract was purchased with a Conservation Partnership Legacy (CPL) Grant secured by MSGS – a first. It is now part of the Kroschel-Holy Cow WMA complex! The Marlin and Mary Jo Huddle Family and I began the process in 2016. It was a challenging journey for all, but the Huddles were understanding and patient. Their Conservation Ethic and Firebird Passion clearly deserve recognition. It was an exhilarating feeling (bordering on spiritual) to present Marlin, Mary Jo, and family a Certificate of Recognition. Afterwards a Huddle family member shared, "On behalf of my family, we again want to thank you for making the dedication a special day for my parents. They were extremely happy

on how it went and talked about it all the way home. Their positive reaction made all our challenges in making this happen well worth it! - 2021 Give to the Max Day Results THANK YOU to the 43 donors that helped MSGS achieve its \$3000 goal!
- The MN Prairie Chicken Society will hold its 49th Annual Meeting on Saturday, April 23, at the Regional Science Center near Glyndon, MN. Congrats to them for recently receiving Pheasant Forever's "Partnership of the Year Award"! MPCS also has a \$1,000 Scholarship opportunity for an undergraduate college student deadline is 1 March. Go to their website for instructions and application.
- <u>The Cupido WMA</u> in Norman County was dedicated on August 6. Much gratitude goes to Pheasant Forever's Build A Wildlife Area and partners that kicked in, including MSGS!
- "Pulse of the Heartland", an article in the fall National Wildlife Federation magazine, was an excellent read about the loss of North America's grasslands, their benefits, available programs, and a bill, the North American Grassland Conservation Act, that will be introduced in Congress.
- Conservation Reserve Program Sign Ups were announced for 2022 The General CRP signup will run from Jan. 31 to March 11, and the Grassland CRP signup will run from April 4 to May 13. Continuous CRP is ongoing. "Farmers, ranchers and private landowners are highly encouraged to consider enrollment options. A better, bolder program, with higher payment rates and other incentives has been rolled out, including climate-smart solutions that generate revenue and benefit our planet."
- The Story of the Stoney Suite, Building a Blind with the Boys Dan Svedarsky strikes again with his ingenuity and fun family activities.
- <u>Lac Qui Parle Land Sale Approved!</u> The MN State Land Exchange Board approved the sale of 80 acres of land owned by Phillip Sonstegard to the DNR, ending an over two year battle by the landowner to sell his land to the state of Minnesota This is a major victory for both private landowners who want to sell land to units of government and public landowners who need access to quality public land for hunting fishing and outdoor recreation.
- Working with fire, traditionally "Vern Northup, the subject in this interview, was and is a good friend.... His comments on the relationship of logging and RX are spot on. While logging has some similarities, there are also significant and great differences in the outcomes. As I looked at the aftermath of Greenwood fire, the differences are apparent and striking. The volume of fallen wood, creation of large cavity trees and the overall numbers of snags, as well as the patchy nature of the burns, are difficult to recreate with a timber sale. Bringing fire more prominently into the management of our WMA/AMAs is worth greater discussion as a group, and with the DNR and USFWS." Craig Sterle, retired MN DNR Forester.

# **Enhancing Habitat Across MN's Sharptail Country**

From Thief Lake WMA in Northwest MN -Kyle Arola, MN DNR - See below photos from current projects. MN DNR Roving Crew members are operating bulldozers with shear blades to treat dense willow stands to enhance sharp -tailed grouse habitat. Over 350 acres have been treated this winter and prescribed burning will be utilized in the coming years to keep the areas open.





From East-central MN – Becca Kludt, Pheasants Forever (PF) - In 2018, MSGS and PF built on their existing partnership by bringing PF's Enhanced Public Lands Program – Open Landscapes Phase I to Firebird territory using Outdoor Heritage Funds. The goal was to enhance 2,910 acres of open landscape habitat in the Northern Forest region to enhance early successional habitat to benefit sharptails and other wildlife. It was viewed favorably by the Lessard-Sams Outdoor Heritage Council and legislature and awarded \$955,000! Work began in winter 2019/2020. To date we've enhanced 1,657 acres, and have another 1,718 acres contracted. Most recently, 151 acres of brush mowing was completed on the Sandstone WMA in Pine County. The \$12,000 in leverage provided by MSGS in July 2021 will help pay for this project. On behalf of Pheasants Forever, I would like to thank MSGS for your support and help in delivering meaningful work that benefits wildlife and the citizens of Minnesota. We look forward to continuing our partnership for Phase II set to start in July 2022.

From Lac Qui Parle WMA in Southwest MN – Walt Gessler, MN DNR - We've had a good winter for getting habitat projects completed –snow depth is not excessive, and we have good frost conditions for heavy equipment. We should complete four tree removal/invasive removal projects this winter on Lac qui Parle WMA. Across the SW, ~ 8 woody removal projects are under contract with DNR. In addition, non-government organizations have another 20-25 active woody removal projects in progress or under contract. The Morris Wetland District has another half dozen cutting projects. Altogether, these projects are benefitting about 3,000 acres of prairie/openland habitats.

New acquisitions and habitat development projects continue across the region. Most new development on WMAs is geared toward prairie and wetland restorations along with facility development for public access.

A positive development (at least temporarily) was closure on the lawsuit between landowner Phillip Sonstegard, MN DNR, and Lac qui Parle County. This lawsuit was the result of Lac qui Parle blocking the landowner from willingly selling his land to DNR. For DNR to purchase land, a willing seller is needed and the local County Board needs to

approve the sale. In this case, the County denied the sale, so the landowner brought suit against the County. In the court decision, the reasons the County gave for not approving the sale were determined to be capricious. After this court decision, the sale was moved forward to the state Land Exchange Board to review. The Board approved the sale.

As noted in this newsletter, we will have our very 1<sup>st</sup> Brush Cut in the SW on March 19! If you need a break from the cold north come down and join us. For you folks in the forest, this will be an opportunity to increase your sun exposure and get a start on spring fever!!!
